- To promote and develop Wingsuit Flying & Speed Skydiving training and competition.
- To establish new World and Continental Wingsuit Flying & Speed Skydiving competition records.
- To present a visually attractive image of the competition jumps and timely standings (scores) for competitors, spectators and media.
- To exchange ideas and strengthen friendly relations between skydivers, judges and support personnel of all nations.
- To allow participants to share and exchange experience, knowledge, and information.
- To improve judging methods and practices.

- JUMP-TANDEM SKYDIVING CENTRE, Letecká 1, 796 01 Prostejov, Czech Republic
- Airfield area of 750 acres, 3Km²







• This huge Airfield is surrounded by fields and grassy areas providing plenty of space in case of any outlandings (or off DZ landings). JUMP-TANDEM SKYDIVING CENTRE is appreciated as one of the safest DZ.

- GPS: 49 26' 42.95" N, 17 7' 51.35" E
- City center of Prostějov town (50.000 inhabitants) is 3 km from the DZ.



3.3 The town of Prostějov is easily accessible by highway or by train. The competition site (JUMP-TANDEM CENTRE) is situated near to the highway.

Car access distances:

Vienna Intl. Airport	180km	1,7 hrs.	by highway
Prague Intl. Airport	260km	2,5 hrs.	by highway

There is frequent comfortable train connection from Prague to Olomouc (15km from Prostejov) - Leo Express, Regio Jet, Pendolino. From Olomouc take Taxi, rent a car or use DZ shuttle. The orgaiser can help with arranging the train tickets and car rental.

Transfer of complete delegations from intl. Airport Brno, intl. Airport Vienna or Railway Terminal Olomouc to the competition site may be arranged by the organiser upon request. (The transfer will be not provided for individual competitors).

4 Transportation

Transport to competition venue is best possible by car. There are many car rental companies at all recommended airports.

Local transportation is provided by DZ shuttles from/to hotels for additional package as in paragraph 5 of this Bulletin 1.

5.2 Number of delegation members / teams allowed:

- 1 Head of Delegation
- Accompanying persons and additional support personnel including interpreter

Each delegation for Wingsuit Flying competition may be composed of:

- 1 Team Manager/Coach
- A maximum of twelve (12) performance competitors
- A maximum of four (4) acrobatic teams
- For delegations with three registered performance competitors, the competitors will automatically form the national WS-P team upon registration unless the Head of Delegation or Team Manager disagrees.
- For delegations with more than three registered performance competitors, the delegation may nominate three of its performance competitors to form the national WS-P team. This must be done before the exit order is finalized at the competitors meeting.

Each delegation for Speed Skydiving competition may be composed of:

- 1 Team Manager/Coach.
- A maximum of twelve (12) competitors ten places open to male or female competitors and two places exclusively for competitors from whichever is the gender minority.
- For delegations with 3 registered competitors, the competitors will automatically form the national SP team upon registration, unless the Head of Delegations or Team Manager disagrees.
- For delegations with more than three registered competitors the NAC may nominate 3 of its competitors to form the national SP team. This must be done before the starting order is finalized. There is only one SP team per NAC.

5.3 Registration procedure:

All registration forms with payment instructions are available at ec2023.jump-tandem.cz/ registration as well as a part of this Bulletin No. 1.

The organizer will accept filled and signed registration forms sent to <u>sport@jump-tandem.cz</u>. The entry form has to be filled and signed by NAC authorised person only (not from an individual competitor).

5.4 Payment procedure:

The delegations can use a wire transfer payment method.

The whole amount must reach the organiser's account. All Bank charges must be paid by the sender. We recommend to use the "OUR" payment method.

In the case that this condition is not fully fulfilled by the entry deadline, the remaining money must be paid in cash, in Euros, before any jumps may be made.

All payments must be made in Euros.



6 **Drop zone facilities**Competition layout



• JUMP-TANDEM facilities can serve as many as 600 skydivers at one time. It consist of the Main Building 970m², Hangar 330m² and site buildings 120m². During the competition there will be additional temporary buildings to serve for the competitors.



Fulltime DZ Facilities:

- Indoor packing 470m2
- Restaurant with delicious dishes and drinks available whole day
- Professional rigging service
- Swimming pool
- Observation deck
- Air-conditioned judging rooms

- Hourly capacity of one L-410 is 54 PAX
- Daily capacity of two L-410 during the competition is 1200 jumps
- Left door dimension (H) 150 cm x (W) 126 cm
- The LET-410 was successfully used during all FAI FCE held at JUMP-TANDEM SKYDIVING CENTRE since 2005.

One week before the competition there is competition training at the DZ (for registered teams).

You are welcome to jump from the same aircraft which will be used during the competition.

12 Judging & Scoring

Skyderby scoring system will be used for competitions Wingsuit Performance and Speed Skydiving

InTime Scoring system will be used for Wingsuit Acrobatics competition FlySight units will be used by WSP and SP competitors to record the real-time, three-dimensional (3D) position of the competitor.

Results will be published on-line at <u>results.worldskydiving.org</u> and on the competition website <u>ec2023.jump-tandem.cz</u> and on site on the official information board.

Judges training course: will be not organized during this competition. Evaluations for Speed Skydiving and Wingsuit Flying is possible.

13 Medical / emergency details

A First Aid and CPR trained person will be at the competition site during the whole event. The nearest fully equipped hospital with anaesthesiology and resuscitation department, trauma department etc., is about 10 km from the DZ in Prostějov city.

Typical ambulance response time is 5 minutes. Heliport with medical helicopters is in Olomouc city about 5 minutes flight time. There is another completely equipped hospital in Olomouc city.

14 Insurance details

All competitors must have full third-party liability insurance (minimum amount of coverage 3.000.000 CZK) valid in the Czech Republic (European Union) and also have insurance to cover medical expenses in the case of injury and repatriation (minimum amount of coverage up to the competitor). In case of any problems please contact the organizers. Any damage to the hotels etc. is the responsibility of the people involved. Personal items and equipment are the participants' responsibility.
